Rules of Play

- Ticket purchasers must be 19 years of age or older.
- At the end of each month, Payroll will provide a list of payroll deduction lotto participants. Only these participants will be eligible for that draw.
- If you do not work in the pay period you do not play.
- Upon receipt of your consent received by RIVERCITY INCLUSION, a notification will be sent via email. Because of cut-off dates for RIVERCITY INCLUSION pay periods, it may take up to 2 weeks from receiving the form before payroll deductions begin.
- Players will be notified of updates or changes to the 50/50 Payroll Lotto via email. Please provide a valid email address. You are responsible for keeping your contact information up to date.
- Winners are required to present one piece of photo identification to receive their cheque from RIVERCITY INCLUSION
- Participants will be entered into the eligible draw period **December 26, 2022-December 22, 2023**
- Requests to leave the lotto are at the discretion of the employee. To withdraw your name from the RIVERCITY INCLUSION 50/50 Employee Payroll Lotto, you must notify our office in writing. Because of cut-off dates for RIVERCITY INCLUSION pay periods, it may take up to two weeks from receipt of request before the withdrawal is complete.
- Please note that the annual cost of lotto participation is not considered a charitable donation by the Canada Revenue Agency and is therefore not eligible for a tax receipt.
